A busy end to the year

We're now into October and the year-end is drawing closer – but the run in to the end of the year will be very busy with multiple key consultations and submissions needing to be done.

The Electricity Authority will be releasing its wholesale market review and issues paper on the 27th of this month, which will be of great interest to many within the wider sector. While we had originally expected to see this in mid-September, it is important that the Authority gets its review and issues paper right. At the same time, that's little consolation for those suffering from poor market outcomes with another six-weeks of pain in the meantime.

We also have the Transmission Pricing proposal coming out for consultation mid-October. There will be intense focus on what Transpower and the Authority have come up with, including on potential impacts in different parts of the country.

The old axiom is good things come in threes, and we have government consultation on draft emissions reduction plans out soon, with submissions due in mid-November. Indications are that government is looking to step up is level of ambition which could bring into focus the idea of a just transition and the ability of some to make rapid, immediate emissions reductions.

The renewable electricity generation project becomes a reality

We're delighted to see the recent announcement that Oji Fibre Solutions and Pan Pac Forest Products have entered into 10-year deals with Contact Energy to purchase renewable electricity.

The renewable electricity generation project is part of the commitment of major electricity users to find meaningful and practical solutions to our carbon reduction challenge.

The recently announced deals are about large energy users stepping up to provide leadership in emissions reductions, with the goal of delivering real reductions in carbon emissions over the next decade and at the same time realising a commercial win-win for purchasers and sellers of long-term renewable electricity contracts.

MEUG's role was to bring participating companies together and help advance the project through to where commercial negotiations with potential suppliers could begin. We have not been involved in the commercial negotiations.

We would like to acknowledge the role of project manager David Thomas throughout the last two years in bringing these deals to fruition.
