The looming mitigation or adaptation debate

Many in the industry will gather at the Downstream Conference this month, where much of the agenda focuses on climate change-related issues – the pathway to net zero, how do we ensure secure supply and build the infrastructure needed for the future, and what are the market settings required to support all of this. This includes both mitigation (how do we minimise the amount of warming and volatility) and adaptation (how do we future-proof our infrastructure and supply in what will be a warmer, more volatile, future).

One interesting development is the increasing frequency of arguments for adaptation over mitigation amongst those on the political left¹, particularly following the devastation resulting from Cyclone Gabrielle. It will be interesting to see if and/or how this debate occurs at Downstream and within our industry in coming years. With the United Nations forecasting the world will likely go beyond 1.5 degrees of warming around 2026 (at least for a short period), the one thing we know is the debate will happen.

On the consumer side, we will be looking at the debate at least in part through the affordability lens, i.e., how do we navigate these issues in a way that produces positive outcomes at least cost.

MDAG options paper an important contribution to the pathway forward

A valuable contribution to work on how we transition to a more renewable future is the work of the Market Developments Advisory Group (MDAG). MDAG is currently consulting on their paper "Price discovery in a renewables-based electricity system, Options paper 2022" and we would encourage everyone to submit if they're in a position to do so.

From a consumer perspective, MEUG is particularly interested in Chapter 10 which focuses on strengthening competition given the implications for wholesale electricity price-setting and maintaining public confidence that competition is influencing price setting. MDAG has previously found that if increased volatility hinders new generation entry, then the move towards 100% renewable generation is likely to result in higher average prices.
